# Gora To Sit On High Court

A White House source has reported (leaked) that BLS Professor Joel Gora is being considered for nomination to the U.S. Supreme Court. Professor Gora had little comment, except to say that he was "of course, pleased" that he was apparently being considered, adding that he hoped he would not lose his tenure at BLS if he took the position on the High Court.

Although there are presently no vacancies on the Court, the White House has been preparing a list of candidates, if any of the present Justices should leave the Court. Gora has been supported in these discussions by Vice President George Bush, who has reportedly struck up a friendship with Gora during frequent visits to the shirt counter at Brooks Brothers.

President Reagan has been encouraging development of "the Gora option." White House sources quote President Reagan as saying that he lately thought he'd been "all wrong" on civil rights, and wanted to show a change in direction. White House counsellor Ed Meese III has been adamant in his disapproval of "the Gora option," saying that "we shouldn't sap academic institutions just to find people to work for the government."

Meese reportedly supports Federal Judge Robert Bork for the next seat on the bench, and may resign if Gora is ever nominated. Professor Gora said that if the report were true, he would consider his nomination "more of a service to the country than any opinion he could ever write."

Professor Richard Farrell will conduct New York Civil Practice completely in Yiddish next fall semester. The material will be the same, but the curriculum will be covered backwards, beginning with provisional remedies and ending with a description of New York courts.



The Brooklyn Law School placement office will permanently close and cease operations effective June 1, 1982. The announcement was made in a letter sent to students, faculty and recent graduates. A variety of reasons for the closing were given by administration officials.

"I don't foresee much effect," Dean Lewis Kerman predicted, adding that he considered the placement office "just an appendage." Dean Kerman also revealed a plan to change the placement office to an apartment referral service, asking "Do you know what a fortune we could make? The brokers in this neighborhood are all getting rich and we could clean up, too. We have a school full of apartment hungry students, and at three hundred bucks a throw, we'll make some profit."

Dean Johnson said that national economic conditions dictated the closing, "What good is an employment office in a depres-

sion?" He added that he never knew anyone who ever got a job through the placement office, anyway,

Ninth-floor sources who wished to remain anonymous indicated other reasons for the closing, including demands by Dr. Paulette LaDoux for free access to the Law Review Library and use of an "800" phone

When confronted with these accusations, Dr. LaDoux was incensed, "Why shouldn't I be able to use their library? Why should I have to shlepp downstairs, then back upstairs, just to look at a stinking New York Supp?" Reminded that she was not a lawyer, Dr. LaDoux responded, "Well, neither are the students."
