I. Update on First-Year Courses That Focus on International or Comparative Law¹

Since our report last year,² there are at least ten more required or optional first-year courses that focus on international and/or comparative law. As of the end of November 2017, twenty-nine schools reported that they typically offer these types of courses. Reporting schools listed more than forty-one courses, many of which are doctrinal in nature, with the remaining being skills-oriented. Although most courses are offered in the spring, a few are offered during the fall term. Most interesting is that more than a dozen are *required* courses. The specific offerings follow:
